**Any entries arriving late will
NOT be judged!!!**

Report cards for all 6 shows will be e-mailed on one form, together, by **July 10, 2012**.

Shows (1 per show via "walls", and the balance via PowerPoint) will begin **July 22, 2012** & end **November 1, 2012**.

Medals will be mailed by **September 30, 2012**, and **HM's** will be included.

Early Bird Discount is 25% if entry arrives at the address on the below mailing label by May 1st, 2012

KEEP THIS IN MIND & PLEASE REMEMBER

That this years NORGA Small Print Circuit is a NO-RETURN circuit, which means that all entered prints will be destroyed by the 15th of November, 2012. With the addition of 2 new groups working the circuits of Georgia in 2011 the problem is that they're not print makers and the extra manpower needed for a print circuit is thinner than ever! The very existence of the NORGA Small Print circuit is in jeopardy, whereas the digital circuits are laden with workers at this time.

You will note that the judges, full rules, comments and such are now shown on the Circuits of Georgia web site, rather than here on your mailable entry form. With the increase in sections offered to you, the photographers who support the circuit, we had to go to an additional page for the full entry forms, and to a second weekend of judgments.

One thing to keep in mind is that you must put your email address on the forms, and **mail the prints early** enough to arrive here in time. All the prints now are worked and then shipped UPS to Georgia.
